

Monitoring Committee

The Monitoring Committee's mission is to monitor the implementation and progress of the Operational Program of the North Aegean Region

It was set up on 18.3.2015 by a decision of the Regional Governor of the North Aegean (Government Gazette 541 / B / 6.4.2015). The **Chairman** of the Monitoring Committee is the North Aegean Regional Governor and its members with **voting rights**:

- Representatives of the NSRF management, coordination and certification authorities
- Representatives of public authorities, specialized services of Ministries of policy areas related to the Program
- Representatives of the local authorities
- Representatives of the economic and social partners and non-governmental organizations.

The Monitoring Committee shall be composed of representatives of the Special Services of the National Coordination Authority, the Financial Control Committee, the Directorate-General for Public Investment, the European Investment Bank, as well as representatives of the European Commission.
